#### **ARTICLE 1 MATCH REPORT & NOTIFICATION OF RESULTS**

- 1.01 (a) Official match report forms must be used for all matches.
- 1.02 So that press, website and other need to know media can be informed quickly of results and to maintain accurate records, upon conclusion of the match it is the responsibility of the match hosts to:-
  - (a) SMS the results to the following numbers - 07879843055 - Val Conroy and 07946709273 Gordon Morrison within 2 hours of the conclusion of the match.
  - (b) Post the original match report sheet within 4 days of the conclusion of the match to the NRHA Competitions Director, Val Conroy, 1 Lombardy Road, Sudbury, Suffolk. CO10 1LQ
- 1.03 Failure to observe these rules shall result in the Home Team/Match Host being penalised with:-
  - (a) Their forfeit of each affected match
  - (b) Deduction of three (3) competition points
  - (c) A fine of £50 deducted immediately from their competition bond
